

## You CAN afford a Christian Education at JRHS

A Christian education at Jesse Remington High School is accessible to more families. To meet this goal there are three sources of financial assistance available for eligible families:

- Education Tax Credit Scholarships (ETCs);
- Education Freedom Accounts (EFAs); and
- JRHS Financial Aid

## **ETC and EFA**

#### JRHS Financial Aid

We recognize that families have differing means and resources available to dedicate towards Christian education, and we are committed to making the JRHS educational experience accessible to the extent possible. For families who in need of assistance beyond EFA and ETC, and also qualify, may apply to the JRHS Financial Aid Fund.

In order to receive Financial Aid from JRHS, the Board requires:

- Families must apply to the Children's Scholarship Fund of NH (ETC and EFA);
- Families must complete an application for admission, and students who may qualify for Financial Aid must meet our admissions standards set forth in our Policy and Procedure Manual;
- Families must complete our secure third-party agency, <u>FACTS Grant and Aid</u> application. FACTS evaluates the application based on national and regional data and makes a recommendation to the school. Their recommendation, which is based on the family's economic profile in consideration of FACTS' national assessment data, weighs heavily in determining the Financial Aid award. ## **Automated Payment System**

Tuition payments are made through FACTS via automatic bank withdrawals or credit card payments. Families set up a new account each year by accessing FACTS during Online Enrollment. All other student fees are paid using FACTS Incidental Billing. Other payment arrangements can be made if required.

## Full-Time School Program

## **Optional & Other Fees**

Jesse Remington offers opportunities beyond the core curriculum including competitive sports and club activities. These are **optional activities**. Costs associated with these activities are charged as fees.

#### Clubs

Options vary depending upon availability and interest. Examples of past clubs include:

- Equestrian (Estimated \$200)
- Rock Climbing (Estimated \$125 \$175)
- Mountain Biking
- Marksmanship
- Skiing (Estimated \$280-\$360)

Cost varies depending on the club activity. Estimates provided for some.

## **Mission Trip**

Each year students participate in a mission trip. A school fund pays a portion of the cost through fundraising. Students may solicit support and the family is responsible for the balance of the cost. The following are estimated costs: Domestic trip - \$1,000, International (abroad) trip - \$2,300. Typically, a \$200 deposit is required about 3 months prior to the trip. The family balance is due about 30 days before the trip. Each year we offer a domestic trip option.

#### **Books**

Families are responsible for purchasing books and the required booklist will be available by August 1, 2025. Expect book expenditure to be \$300 to \$500, subject to course requirements and vendor rates.

## **Fundraising**

Fundraising events take place throughout the year to help defray tuition, athletic and overall mission trip costs. Students and families are asked to support these efforts as best they can.
